This file will be downloaded onto your computer (in the downloads folder), and the same .zip file will be sent to your listed email address.

Step 4 - Sign

You should have your blank forms with all the correct information for you and your 4 x witnesses on them.

Print these in colour, and get your witnesses to sign where need on each form.

You will now print these out in colour, and complete them by signing in blue ink. Affix your right thumb print to the universal declaration, in red ink, next to your autograph as indicated.

Ask your 4 witnesses to sign where their names appear, on the Autograph line provided. *Your 4 witnesses may sign as per their usual signature, make sure they use a blue pen.*

You will notice that each witness has a different position on each page.

You should have 1 x Universal Declaration, 2 x Witness forms and a 2 page cover letter. The witness forms will have the selfie you uploaded of yourself in the block as indicated.

As a living man or woman, you now use an **autograph**. Your name must be written as shown below. It must be legible, no fancy stuff for you anymore. You will also need to add a red, right thumb print to touch or overlap the last letter in your surname.

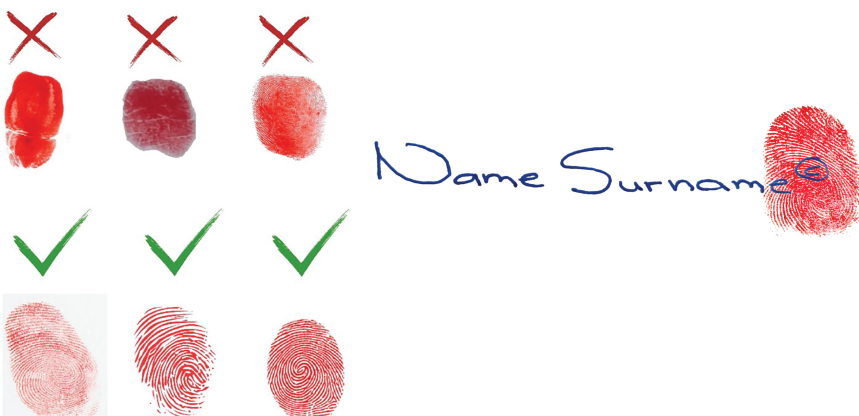
Step 5 - Seal

Your right thumb print must have visible ridges on the print...

Some tips: you can use a red marker, or red ink pad (avoid using too much ink). Place a few prints on a clean white piece of paper. Do not press down too hard.

(practice makes perfect... before doing the one on the universal declaration.)

You will need to take a photo of a few of these prints on a blank piece of paper to upload to the various platforms. Take a picture with your phone, in the sun, and crop the picture close to the group of prints. This will give the best quality.

Universal Public Declaration of Political Status
Established under International- and National Law

It is my position and declaration that I was born within the borders of the country, South Africa, a sovereign state, and that I have never knowingly and willingly departed from my birthright standing. I declare:
I am of age, competent, and acting without fear or duress. I declare that to the best of my knowledge and according to Witnesses, I was born on the land and the soil of South Africa on the 20 day of March in the year 2008, and I claim no other nationality.

I do claim my divine creation approximately nine months prior to the day I was born and claim my unique DNA from the moment of that creation, together with all other attributes and creations of my mind and body.

I do claim my private Given Name First Middle Surname (C*), which is a gift to me, and also claim right of use and trademark and patent as Holder in Due Course over all variations, styles, permutations, orderings, punctuations and derivatives of my Given Name and any other Name associated with me.

I do not accept any foreign emoluments or titles or offices of personhood such as "Mister", "Missus", "Miss", or "Doctor", nor do I voluntarily accept any conferred or assumed obligations of any foreign citizenship or contract; I adopt no political allegiance to any foreign state, country, prince, nation, king, queen, flag, government, or principality existing outside of or within the borders of my country, except that I reserve the right to move my household and establish my home in another district if I so choose;

I am living now in the district known as Mossel Bay, and I declare my intention to stay in this physical location and within the borders of this district and to be counted as one of its people.

I hereby scribe my signature as a living being and my thumb print as proof of my unique and permanent identity, and I make manifest this Universal Declaration of Political Status on this 2nd day of June in the year 2026.

Step 6 - Cover Letter

Your cover letter should be ready for your autograph on page 2!

Dont forget, you will now use **blue ink**.

Step 7 - Completion of documents

You now need to send a copy of these documents to Home Affairs.
(cover letter - 2 pages, 1 x Universal Declaration, 2 x Witness testimony pages)

The easiest way to do this is to scan your documentation:- Take a picture with your phone... usually, under 'more settings', there is a 'scan document' option - save them as a .pdf file.

Make sure your scan is crisp and easy to read. Also, make sure that the red watermark is visible on your scanned documents. Keep these scans on your computer, as you will need to upload them to 2 more platforms.

Send it via the registered email portal:- <https://saporeg.co.za/individual> and send the registered email with all your documents attached to: hacc@dha.gov.za.

- You will need to create your own account.
- You will need to add money to your wallet to pay for your registered email.
- Fill in the details, choose the file/s to send, and away you go!

You will receive a report once the email has been delivered, you must keep this as proof of delivery, and also upload it to the LRO when you record your documentation.

Always keep your original, signed documents together in a safe place, for your own records.

Congratulations!

You are now back on the land and soil jurisdiction, and recognised as a living man or woman.

In the next section, we will explain how to upload your documents on our **Land Recording Office**. The LRO is there to keep a copy of your documents for interested parties to prove that you are now firmly in the Land and Soil Jurisdiction!

After your documents are published on the LRO, you will hold these documents, ready for when the **New Banking System** is open, where you will be effectively, opening your profile, ready for your account.
